

ANNUAL MEETING OF THE MEMBERSHIP - ELECTION RESULTS

FEB/MAR 2014

The Annual Meeting of the Membership was held on Thursday February 13th at 7PM in the Association's Clubhouse. There were four directors to be elected for a two year term. The following are the results as presented to the membership by the election inspector:

The board would like to extend its gratitude to Jim Turke and Frank Hedges for their many years of service and valuable contributions to the board and the community. We hope they will continue to support the board for many years to come.

Minutes of the 2013 Annual Meeting were approved (50 votes in favor, 0 votes against) and the IRS Resolution to allocate excess operating funds to the reserve account was approved (47 votes in favor, 3 votes against). President, Jim Foley, presented 2013 accomplishments and 2014 goals. Here are some of the points raised:

Accomplishments for 2013

- Clubhouse phase II is complete: this comprised interior renovation, including painting, new bathrooms, security system, and carpeting. The new furniture is on order. Jim thanked the entire board for their individual contributions, and called phase II a great team effort.
- Wood project: preparations started in the Summer. The last time the Vineyards had comprehensive wood repair was over 10 years ago. Hidden problems have been identified and remedied, as work is continuing into 2014.
- Painting of the Vineyards: pressure washing and re-painting started in the Fall and is continuing into 2014.
- FHA Certification: in 2013 Jim Foley put in countless hours to successfully obtain FHA Certification, and the Vineyards became the only condominium complex in Saratoga to have FHA Certification.
- HOA Documents: in anticipation of the Davis-Sterling Act updates, the board authorized attorney Jeff Barnett to update the Vineyards CC&Rs, Bylaws, and Rules and Regulations.
- · Newsletter: Jim thanked Anna Scicinska and the newsletter committee members for work on The Grapevine
- · Ongoing maintenance: Jim reported on concrete repairs.
- Landscaping: Jim thanked landscaping committee chair Chris Burns for the work of her committee, including tree maintenance, the aeration of the Koi Pond, and efforts to save water.
- Garbage collection: garbage dumpsters or recycle bins filled to overflowing have added additional expenses.

Goals for 2014

- Clubhouse phase III: the final phase of the renovations will include a new kitchen in the clubhouse, as well as a new trellis, heater and repairs to the pool-house at the big pool.
- Reserve study: Treasurer Gloria Felcyn spoke about commissioning a reserve study. This financial document needs to be reviewed and updated.
- Community awareness: the board will continue to watch developments of properties surrounding the Vineyards (Abrams property, Quito center, and Highway 85 expansion). Members interested in helping in this endeavor are encouraged to attend public meetings of the City of Saratoga, support community organization *Restore Saratoga*, (restoresaratoga.com) and maintain neighborhood communications through *Nextdoor.com*.
- HOA documents: the board expects to complete an update of HOA documents in 2014.
- Landscaping committee: in 2014 the landscaping committee intend to use more drought resistant planting.
- Sewer: Jim Foley will liaise with WVSD to resolve maintenance issues with our main sewer lines and laterals.



THE NEXT BOARD OF DIRECTORS MEETING

The next Board meeting is on Thursday March 13th at 7:00pm.

The agenda for all board meetings is posted in advance at the entrance to the Clubhouse. Monthly meetings are open to all homeowners. The 15-20 minute Open Forum session at the start is an opportunity to have any issues heard by the board, association manager, and others present, and to ask questions about any projects or decisions addressed by the board.

Following Open Forum, the meeting is limited to those issues posted on the agenda. COMMUNITY CORNER - focus on local farmers' markets

Whether you like to spend a leisurely weekend morning, browsing the stalls and stopping for a tasty snack, or are looking for a quick mid-week stop, Saratoga and the surrounding area offers three great outdoor markets.

Saratoga Farmers' Market at West Valley College This large year round market sells seasonal fruits, vegetables and salad greens direct from local California farmers. There are also vendors for flowers, organic eggs, fresh fish, and ready to eat foods. The location is in the parking lot at the West Valley College near the junction of Fruitvale and Allendale Avenue. With over 50 farmers and food producers, you are sure to find something you'll love! Saratoga Village Farmers' Market The mid-week Saratoga Downtown Farmers' Marketplace is small, but offers a good selection of organic fruits and vegetables, flowers, and honey. It is located at Blaney Plaza on the intersection of Big Basin, Hwy 9 and Saratoga Avenue. Several nonagricultural purveyors, including hummus, gourmet food, fresh seafood, premium balsamic vinegars and olive oils, complement the certified farmers' market. 
For a long time we've felt a need for a Vineyards newsletter we encourage a feeling of community and caring. We have grown to about 125 households with some 25 occupied in Phase III.

LANDSCAPING UPDATE from Chris Burns

Our Redwood Trees are Struggling - the Coastal Redwood trees (Sequoia Sempervirens) in the Vineyards are not native to our area. As their name suggests, they are from coastal areas of Northern California and therefore require a lot of rain and fog to remain healthy. After multiple years of drought, redwoods all over the valley, ours included, are beginning to show stress. We have already lost a few and the rest have been limping along. This current severe drought has pushed a few more to the edge. You can see it in the sparse tree tops and brown foliage.

Jim Foley, Tim Dooling (our landscaper), and I have met with our arborist, Gil Mitchell. In order to keep our trees healthy through the drought, our arborist is advising us to deep water our redwoods and to remove the ivy under the trees where we can. Ivy steals moisture from the redwood's root system.

In the coming weeks we will be deep watering and removing ivy under some of the trees. We will let the dropped foliage remain under the trees to create a natural mulch and to help retain moisture. Where feasible, we will plant minimal ferns and other woodsy vegetation. Our goal is to save the Redwoods and create a more natural environment under the trees.

CITY OF SARATOGA NEWS - State Route 85 Express Lane Project

The City of Saratoga has recently received communications on proposed VTA and Caltrans *State Route 85 Express Lanes Project.* This project plans to convert about 27 miles of existing HOV lanes to Express Lanes, and add a second HOV lane between State Route 87 and Interstate 280. An agreement between the City of Saratoga and VTA, signed in 1989, allows the median of State Route 85 to be used for mass transportation. Existing users of the car pool lane will

continue to use these lanes for free. Solo-drivers will have the option to pay to use Express Lanes during commute hours.

An environmental assessment is one of the first steps of the process. Other opportunities for public engagement will include the planning, design, and funding phases. Valley Transportation Authority is currently accepting comments on the Draft Initial Study with Proposed Negative Declaration/Environmental Assessment. The deadline to comment is February 28, 2014.
